WARRANTY

LIMITED WARRANTY - REZNOR® USED-OIL-FIRED HEATERS AND BOILERS

Reznor Corporation warrants to the original owner-user that this Reznor product will be free from defects in material or workmanship. Except as set forth below with respect to the Combustion Chamber and Heat Exchanger, this warranty period is limited to twelve (12) months from the date of purchase by the original owner-user. Any replacement part purchased within the warranty period will be warranted for the unexpired portion of the warranty period only. This Limited Warranty is non-transferable.

EXTENDED LIMITED WARRANTY - REZNOR® USED-OIL-FIRED HEATERS AND BOILERS

HEATERS: Models RA, RAD, and RV - Reznor Corporation warrants to the original owner-user that the Combustion Chamber and/or Heat Exchanger (excluding the Access Door Liner) will be free from defects in material and workmanship for Ten (10) Years from the date of purchase by the original owner-user. Any replacement Heater Combustion Chamber and/or Heat Exchanger within the Extended Limited Warranty period will continue for the unexpired portion of the original Ten (10) Year Extended Limited Warranty. This warranty covers in full (100%) the current List Price of the Combustion Chamber and/or Heat Exchanger for Five (5) Years from the date of purchase by the original owner-user. From the end of the Fifth (5th) Year to the end of the Tenth (10th) Year, from the date of purchase by the original owner-user, this warranty covers a pro-rated percentage of the current List Price of the Combustion Chamber and/or Heat Exchanger as follows: 83% during Year 6; 67% during Year 7; 50% during Year 8; 33% during Year 9; 17% during Year 10. The original owner-user is responsible for the remaining percentage of the product List Price. This Extended Limited Warranty is non-transferable.

BOILERS: Model RAB - The Boiler Combustion Chamber and Heat Exchanger (excluding Liner) are warranted by Reznor Corporation to be free from defects in material and workmanship for Three (3) Years from the date of purchase by the original owner-user. Any replacement Boiler Combustion Chamber / Heat Exchanger within the Extended Limited Warranty period, will continue under warranty for the unexpired portion of the original 3-Year Limited Extended Warranty only. This Extended Limited Warranty is non-transferable

LIMITATIONS AND EXCLUSIONS

Reznor Corporation's obligations under this warranty and the sole remedy for its breach are limited to repair, at its manufacturing facility, of any part or parts of its Reznor products which prove to be defective; or, in its sole discretion, replacement of such products. All returns of defective parts or products must include the product model number and serial number, and must be made through an authorized Reznor distributor or arranged through Reznor Customer Service. Authorized returns must be shipped prepaid. Repaired or replacement parts will be shipped by Reznor F.O.B. shipping point.

1. The warranty provided herein does not cover charges for labor or other costs incurred in the troubleshooting, repair, removal, installation, service or handling of parts or complete products.
2. All claims under the warranty provided herein must be made within ninety (90) days from the date of discovery of the defect. Failure to notify Reznor of a warranted defect within ninety (90) days of its discovery voids Reznor's obligations hereunder. Proof of original purchase or original installation date may be required. In addition, improper use of the product or failure to properly maintain the product will void the warranty.
3. The warranty provided herein shall be void and of no effect in the event that (a) the product has been operated outside its designed output capacity (heating, cooling, airflow); (b) the product has been subjected to misuse, neglect, accident, improper or inadequate maintenance, corrosive environments, environments containing airborne contaminants (silicone, aluminum oxide, etc.), or excessive thermal shock; (c) unauthorized modifications are made to the product; (d) the product is not installed, operated, or maintained in compliance with the manufacturer's printed instructions (including, but not limited to, lack of cleaning); (e) the product is not installed and operated in compliance with applicable building, mechanical, plumbing and electrical codes; or (f) the serial number of the product has been altered, defaced or removed.
4. The warranty provided herein is for repair or replacement only. Reznor Corporation shall not be liable for any loss, cost, damage, or expense of any kind arising out of a breach of the warranty. Further, Reznor Corporation shall not be liable for any incidental, consequential, exemplary, special, or punitive damages, nor for any loss of revenue, profit or use, arising out of a breach of this warranty or in connection with the sale, maintenance, use, operation or repair of any Reznor product. In no event will Reznor be liable for any amount greater than the purchase price of a defective product. The disclaimers of liability included in this paragraph 4 shall remain in effect and shall continue to be enforceable in the event that any remedy herein shall fail of its essential purpose.
5. THIS WARRANTY IS THE SOLE AND EXCLUSIVE WARRANTY FOR REZNOR PRODUCTS, AND IS IN LIEU OF ALL OTHER EXPRESS AND IMPLIED WARRANTIES. REZNOR CORPORATION SPECIFICALLY DISCLAIMS ALL OTHER EXPRESS AND IMPLIED WARRANTIES, INCLUDING, BUT NOT LIMITED TO, ALL IMPLIED WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE. No person or entity is authorized to bind Reznor Corporation to any other warranty, obligation or liability for any Reznor product. Installation, operation or use of the Reznor product for which this warranty is issued shall constitute acceptance of the terms hereof.
6. The start date of the warranty period shall not exceed twenty-four (24) months from the date of manufacture.
